What Topics Will I Study in This Subject?

In the AQA Law course at Ridgewood, you will cover the following key areas over two years:

Year 1:

- **Paper 1: Criminal Law**
 - Personnel involved in criminal trials
 - Roles of the jury, judge, barristers, and solicitors
 - Criminal courts and funding in criminal cases
 - Magistrates and sentencing
 - General elements of liability, fatal and non-fatal offences, property offences, general defences
 - Problem-solving skills and practice
 - Role of judges in making law, statutory interpretation, crime theory, law and justice, law and society
- **Paper 2: Tort Law**
 - Nature of civil law
 - Civil courts, roles of legal personnel, funding, and alternative dispute resolution
 - Basic negligence, psychiatric injury, private nuisance, Rylands v Fletcher, and vicarious liability
 - Problem-solving skills and practice

Year 2:

- **Paper 2: Tort Law (continued)**
 - Revision and in-depth evaluation of tort law concepts
- **Paper 3: Contract Law**
 - Parliamentary law making, delegated legislation, and the role of the EU
 - Introduction to contract law, making contracts, contract terms including the Consumer Rights Act 2015, exclusion clauses, vitiating factors, discharge of contract, and remedies
 - Problem-solving skills and practice
